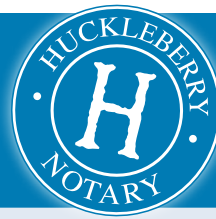

- You will receive your notary seal from us and your notary certificate from the Secretary of State. You must fax or mail us a copy of your notary certificate so that we can manufacture your expiration stamp.

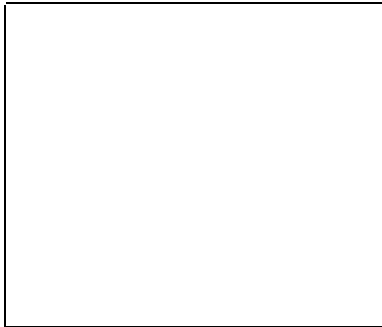
