  - sign the Declaration in the presence of the Notary, using your name exactly as stated in the "Applicant Information" section
  - · date the Declaration at the same time you sign it
- 4. The Notary Public must
  - affix his or her stamp or seal in the appropriate place
  - · date the notary certificate
  - sign his or her name exactly as it is on the stamp or seal
  - print his or her name under the signature
  - · fill in the county and expiration date

- You must swear or affirm and sign the Declaration of Applicant in front of a notary public.
- If you are renewing your appointment before your expiration date, complete only the Applicant Information and Applicant Personal Data sections of the application.
- Your Social Security Number is required [RCW 26.23.150].
- The state requires your last name and at least your first and middle initials [RCW 42.44.050].
- Your printed name on the Application (Page 1) must match the printed name and signature on the Declaration of Applicant (Page 3).
- Have your three endorsers fill out and place their signatures under the Endorsements Section.
- If you answered any questions in the **Applicant Personal Section** "Yes", you will need to explain the answer in the space provided.

# Select additional Notary supplies from our Order Form

- Washington notaries should use a journal as recommended by the State of Washington select item B from the order form.
- **E&O Insurance is highly recommended** as it protects you the notary. Notary Bonds protect the public, not you the Notary Public.
